I am directed to refer to the approval of the competent authority to release an amount of Rs.4,80,00,000/- (Rupees Four Crore Eighty Lakh Only) as 1st installment for Upgradation of 4 Existing Degree Colleges to Model Degree Colleges at the central: state share of 60:40 to be incurred to the State Government of Bihar under Rashtriya Uchchatar Shiksha Abhiyan (RUSA). Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

- Bihar comes under the General Category State, the funding pattern is 60:40. The funds being released is 1st installment for Upgradation of 4 Existing Degree Colleges to Model Degree Colleges is Rs.4,80,00,000/- at the central: state share of 60:40 to be incurred to the State Government of Bihar under Rashtriya Uchchatar Shiksha Abhiyan (RUSA). Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the installment of the Central grant released.
- The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.
- On receipt of sanction letter, the Principal Accounts Officer may issue an advice to the Reserve Bank of India (Central Accounts Section), Nagpur for affording credit of the sanctioned amount to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of the State Government as well as Director, Higher Education of the State with a copy to the undersigned.   was received, should be submitted to the Ministry within 12 months of the closures of the
  financial year.
- 10. The grant has been sanctioned in accordance with the pattern approved by the Ministry of Finance and is in conformity with the rules and principles of the scheme as approved by the Ministry of Finance.
