

**MINUTES OF THE 14th MEETING OF THE PROJECT APPROVAL BOARD (PAB) OF RUSA
HELD ON 17th SEPTEMBER, 2018**

The 14th meeting of the RUSA PAB was held on 17th September, 2018 at 14.30 hours in India International Centre, under the Chairpersonship of Sh. R. Subrahmanyam, Secretary Higher Education (HE) MHRD.

The Joint Secretary, MHRD & National Mission Director (NMD), RUSA welcomed the members of the PAB and the participating States.

AGENDA ITEM 1: CONFIRMATION OF MINUTES OF 13th MEETING OF PAB HELD ON 30th JULY, 2018.

PAB Decision: The minutes of 13th meeting of PAB held on 30th July, 2018 were confirmed by the PAB.

AGENDA ITEM 2: PRESENTATION OF PROPOSALS BY INSTITUTIONS APPROVED UNDER COMPONENT 4 (10 Universities @ Rs. 100 cr each)

10 Universities which had been approved in-principle in the 12th meeting of the PAB were invited to make presentations before the PAB on their Action Plans. Based on the presentations, **PAB gave the following decisions:-**

Conditions for Release: The release of grants for the above approved proposals would be dependent on filling up of reasonably high (preferably 70%) faculty positions as on 31st May 2018 or thereafter.

The Institutions need to submit details of activities to be taken up under RUSA 2.0 & must avoid any duplication of activities taken up under RUSA 1.0.

AGENDA ITEM 3: CONSIDERATION OF PROPOSALS UNDER OTHER COMPONENTS ON THE CLF PORTAL

Component 2: Creation of university by way of converting college into Cluster

PAB Decision: The proposal of Maharashtra to form a cluster university with HR College of Commerce as a Lead College was not approved as the State is yet to enact an Act for the proposal approved under this Component of RUSA 1.0. The state was assured that this proposal would be taken up at earliest upon the passage of the Cluster University Act (RUSA 1.0).

Component 3: Infrastructure Grants to Universities

PAB Decision: The PAB approved 2 Universities of Assam for Rs 20 crore each, subject to the condition that the State must keep provision in the State budget for matching State's share for the Universities.

1. Submission of Detailed Project Report
2. The Institutions need to submit details of activities to be taken up under RUSA 2.0 & must avoid any duplication of activities taken up under RUSA 1.0.

Note: - 4 Colleges of Tripura from serial number 15 to 18, for which approval was granted under Infrastructure grants to colleges in 13th PAB & 1 college of Himachal Pradesh at serial number 19, for which approval granted under Infrastructure grants in 12th PAB stands withdrawn.

Component 8: Enhancing Quality and Excellence in select Autonomous Colleges

PAB Decision: The PAB approved the following 29 Institutions @ Rs 5 crore each for Enhancing Quality and Excellence in select Autonomous Colleges. PAB also decided to retain proposal of St Josephs College, Bengaluru (Bangalore) under this component, in case the Institution is cancelled from Component 1 approved in the 12th PAB. This will be re-examined by the State of Karnataka

The entire State Share of 40% for these Institutions need to be borne only by the respective State Governments for both Government & Government Aided Colleges and no contribution is permissible by the institutions within the corresponding State Share of 40%. Any breach of this stipulation would lead to cancellation for the proposals and withdrawal of Central grants. This condition is applicable for all components.

Conditions for Release:

1. Central Grants under RUSA 2.0 would be released only after the utilization and submission of Utilization certificate for the entire amount approved and released under RUSA 1.0
2. The release of grants for the above approved proposals would be dependent on availability / filling up of at least 70% of sanctioned faculty positions as on 31st May 2018 or thereafter.

AGENDA ITEM 6: ANY OTHER ITEM WITH THE PERMISSION OF CHAIR

1. The 1st instalment of Preparatory grants and MMER grants to the UTs of Daman & Diu and Dadar & Nagar Haveli had been released along with Equity Initiatives to the UT of Daman & Diu. However, the UTs were unable to withdraw the funds in the specific financial years due to technical and other issues. **The PAB approved revalidation of grants released to the UTs of Daman & Diu and Dadar & Nagar Haveli.** In case of issues with revalidation, then the grants may be treated as approved afresh under RUSA 1.0. The approval is as follows: Preparatory Grants of Rs. 6.00 crores each to Daman & Diu and Dadar & Nagar Haveli, Rs. 1.8 Cr for Equity Initiatives to Daman & Diu and 1% of central releases as MMER for both the UTs
2. With respect to the norm of releasing grants on availability / filling up of at least 67% or 70% of sanctioned faculty posts, the **PAB approved relaxation of the condition for special category states** for release of 1st instalment. However, subsequent release of instalments will be contingent on faculty recruitment as per the component conditions. With respect to the conditions laid down for all the other units approved under RUSA 2.0, the faculty positions filled up as on 31st May 2018 or thereafter would be considered.
3. Out of the 2 New Professional Colleges of RUSA 1.0 cancelled in the 12th meeting, the **PAB approved allocation of one new professional college each** to the State of Gujarat (Surat) & Nagaland (Dimapur). These professional colleges will cater to the needs of multi-disciplinary professional programs.
4. **PAB accorded cancellation** of D. M. College of Arts, Manipur for the component upgradation of existing degree college to MDC approved in 13th PAB since this college was a part of Cluster University approved in 3rd PAB of RUSA 1.0.

The meeting ended with a vote of thanks to the chair, PAB members and other participants.
