Sub:- Release of Grants to Bihar as 2<sup>nd</sup> installment for Upgradation of 9 Existing Degree Colleges to Model Degree Colleges, Infrastructure Grants to 2 Colleges and 1 University under Rashtriya Uchcharat Shiksha Abhiyan (RUSA).

Sir,

I am directed to refer to the approval of the competent authority to release an amount of Rs.9,00,00,000/- (Rupees Nine Crore Only) as 2<sup>nd</sup> installment for Upgradation of 9 Existing Degree Colleges to Model Degree Colleges, Infrastructure Grants to 2 Colleges and 1 University at the central: state share of 60:40 to be incurred to the State Government of Bihar under Rashtriya Uchcharat Shiksha Abhiyan (RUSA). Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

2. Bihar comes under the General Category State, the funding pattern is 60:40. The funds being released are 2<sup>nd</sup> installment for Upgradation of 9 Existing Degree Colleges to Model Degree Colleges is Rs.5,40,00,000/-, Infrastructure Grants to 2 Colleges is Rs.60,00,000/- and 1 University is Rs.3,00,00,000/- at the central: state share of 60:40 to be incurred to the State Government of Bihar under Rashtriya Uchcharat Shiksha Abhiyan (RUSA). Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the installment of the Central grant released.

3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.

4. On receipt of sanction letter, the Principal Accounts Officer may issue an advice to the Reserve Bank of India (Central Accounts Section), Nagpur for affording credit of the sanctioned amount to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of the State Government as well as Director, Higher Education of the State with a copy to the undersigned. The State will then transfer these amounts to the RUSA bank account of State Higher Education Council (SHEC).

Further, the accounts of Bihar SHEC in so far as it relates to grants-in-aid will be open to inspection by the sanctioning authority and audit both; by the Comptroller & Auditor General of India or by any other designated by him and Internal audit by the Principal Accounts Office of the Ministry of Human Resource Development, Department of Higher Education, whenever it is called upon to do so.

6. The amount is debitable to the following three Heads of Demand No.58-Department of Higher Education:

7. Accordingly, I am directed to convey the sanction of the President to release an amount of **Rs.6,30,00,000/- (Rupees Six Crore Thirty Lakh Only)** as the **General Component** of the 2<sup>nd</sup> installment for Upgradation of 9 Existing Degree Colleges to Model Degree Colleges, Infrastructure Grants to 2 Colleges and 1 University at the central: state share of 60:40 to be incurred to the Government of Bihar, under Rashtriya Uchchar Shiksha Abhiyan (RUSA).

8. The Expenditure of **Rs.6,30,00,000/- (Rupees Six Crore Thirty Lakh Only)** will be debited to Demand No.58-Department of Higher Education from : Major Head 3601 Grants-in-aid to State Government, 06- Centrally Sponsored Schemes 101- Central Assistance/Share, 33-National Education Mission : Rashtriya Uchchar Shiksha Abhiyan (RUSA), 03- Rashtriya Uchchar Shiksha Abhiyan (RUSA) -MUSK, 35-Grants for creation of capital assets, of the financial year 2019-20.

9. A certificate of actual utilization of the grants received, for the purpose for which it was received, should be submitted to the Ministry within 12 months of the closures of the financial year.

10. The grant has been sanctioned in accordance with the pattern approved by the Ministry of Finance and is in conformity with the rules and principles of the scheme as approved by the Ministry of Finance.

11. Necessary Sanction ID has been generated.

12. This sanction issues with the concurrence of Integrated Finance Division's Dy. No.2666, dated 09.10.2019 and funds certified by the IF I Section vide their Dy.No.712/19-IF.I dated 30.10.2019.
